Schedule for Counseling-cum- Admission for M.Ed. Programme for the Session 2014-15 for candidates who:

- 1 have passed the qualifying Examination from the University of Jammu and are permanent residents of territorial jurisdiction of the University of Jammu (Jammu Province).

OR

- 2 have passed the qualifying Examination from any other University other than the University of Jammu but are permanent residents of territorial jurisdiction of the University of Jammu.

OR

- 3 is an employee of the Central or a State Government or a Public Sector undertaking or any other organization recognized for the purpose by the syndicate, posted within the territorial jurisdiction of University of Jammu or son / daughter/spouse of such an employee is as follows:-

**Note :-**

- a) Formula for calculation of merit point
  - i.  $\frac{\text{Marks obtained in theory}}{\text{Total marks in theory}} \times 80$
  - ii.  $\frac{\text{Marks obtained in teaching practice}}{\text{Total marks in teaching practice}} \times 20$

**For Example :** Total marks in theory = 700, Marks obtained in theory = 350

i.  $\frac{350 \times 80}{700} = 40.00$

Plus

Total marks in T.P. = 300, marks obtained in T.P. = 210



ii.  $\frac{210 \times 20}{300} = 14.00$

Therefore, Total merit points = 54.00

- b) The candidates shall bring a crossed demand draft of any bank for the amount of Rs 12,880/- drawn in favour of Director, Directorate of Distance Education, University of Jammu, Jammu. payable at Jammu along with a copy of bank Challan, print out of the filled in online application form and all the requisite documents in original at the time of counseling, failing which their counseling shall not be conducted.
- c) List of documents required at the time of Counseling –cum-Admission (original as well as two photocopies of each document) :
- 1 10<sup>th</sup> Diploma.
  - 2 B.A./B.Sc./B.Com. part I, II & III marks card.
  - 3 B.A./B.Sc./B.Com. Degree Certificate.
  - 4 M.A./M.Sc./M.Com. Marks card (if applicable).
  - 5 M.A./M.Sc./M.Com. Degree Certificate (if applicable).
  - 6 B.Ed. Marks Card.
  - 7 B.Ed. Degree Certificate.
  - 8 Provisional Degree or Degree of last qualifying Exam.
  - 9 Migration Certificate (if applicable).
  - 10 State subject certificate.
  - 11 Six(6) passport size photographs.
  - 12 An Affidavit in original duly attested by Notary (format to be downloaded from the website).
  - 13 Certificate from an employee of the central or state government or public sector undertaking or any other organization recognized for the purpose by the syndicate, posted within the territorial jurisdiction of University of Jammu or son / daughter/spouse of such an employee.
- d) The merit of candidates is subject to authentication of the original documents at the time of counseling.
- e) Counseling - cum - Admission shall be made strictly according to the merit and availability of the seats.
- f) Invitation to counseling shall not guarantee the right to admission.
