Online application on prescribed format are invited from eligible in-service candidates for admission to B.Ed. programme through Distance mode for the Academic Session 2024-2026. Application forms are available on website www.distanceeducationju.in from 30-10-24 onwards along with detailed information about the admission process.

**<u>Eligibility</u>:** - The candidates fulfilling the following conditions shall be eligible to seek admission in the B.Ed. programme in ODL mode at Centre for Distance & Online Education(CDOE), University of Jammu, Jammu.

- Candidates with at least 50% marks (45% for SC/ST candidates) either in the Bachelor's Degree (10+2+3 pattern) and / or Master's Degree in Science/ Social Science/ Humanity, Bachelor's in Engineering or Technology specialized in Science and Mathematics with 55% marks or any other qualification equivalent thereto, are eligible for admission to the programme.
- 2. Who are serving as full time teachers in the recognized schools till date (Primary/Secondary/Higher Secondary Levels), within the territorial jurisdiction of the University of Jammu, can apply.
- 3. Who possess a minimum of two years teaching experience of a recognized school (Primary/Secondary/ Higher Secondary Level) either at a stretch or in parts at the time of submission of application form for admission, can apply.
- 4. First preference will be given to the candidates who have completed Diploma in Education / Diploma in Elementary Education/ or trained in service teachers in Elementary Education.

Applicants are advised to fill the form <u>ONLINE</u> with the correct particulars and take out the print of the filled in form for the personal record for further use.

ONLINE FORMS AVAILABLE FROM-: **30-10-24 to 15-11-24 upto 4pm**.

#### Admission Process:

- Fill the application form along with application fee (Rs 500/-) online and upload the relevant document.
- The committee will scrutinize the documents and accept/reject the application.
- If accepted, the candidate will submit admission fee of Rs 40,000/- online.
- The admission is provisional subject to the verification of original documents
