One-Day Workshop on SLM and PPR as per UGC Regulations (28th October 2024) organised by Centre for Distance & Online Education (CDOE), University of Jammu

A one-day workshop on *Self-Learning Material (SLM) and Programme Project Report (PPR)*, aligned with the UGC Regulations 2020, was held on 28th October 2024 at CDOE, University of Jammu. The workshop, hosted by the Centre for Distance & Online Education (CDOE), aimed to provide participants with essential insights on preparing the Programme Project Report (PPR) and crafting effective Self-Learning Material (SLM) for distance and online education programs.
