B.Ed. ADMISSION NOTIFICATION

(SESSION 2026-2028)

Online applications on prescribed format are invited from eligible in-service candidates for admission to B.Ed. programme through ODL mode for the Academic Session 2026-2028. Application forms are available on website www.distanceeducationju.in from 10-08-26 onwards along with detailed information about the admission process.

Eligibility: - The candidates fulfilling the following conditions shall be eligible to seek admission in the B.Ed. programme in ODL mode at Centre for Distance & Online Education (CDOE), University of Jammu, Jammu.

1. Candidates with at least 50% marks (45% for SC/ST candidates) either in the Bachelor's Degree (10+2+3 pattern) and / or Master's Degree in Science/ Social Science/ Humanities, Bachelor's in Engineering or Technology specialized in **Science and Mathematics** with 55% marks (50% for ST/SC) or any other qualification equivalent thereto, are eligible for admission to the programme.
2. Who are serving as full time teachers in the recognized schools till date (Primary/Elementary Levels), within the territorial jurisdiction of the University of Jammu, can apply.
3. Who possess a minimum of two years teaching experience of a recognized school (Primary/Elementary Level) either at a stretch or in parts at the time of submission of application form for admission, can apply.
4. First preference will be given to the candidates who have completed Diploma Education/ Diploma in Elementary Education/ or trained in service teachers in Elementary Education.

Applicants are advised to fill the form **ONLINE** with the correct particulars and take out the print of the filled in form for their personal record for further use.

Important Dates: -

ONLINE FORMS CAN BE FILLED FROM-: 10-08-26 to 31-08-26 up to 4pm.

Admission Process:

- Fill the application form along with application fee (Rs 500/-) online and upload the relevant documents.
- The committee will scrutinize the documents and accept/reject the application on the basis of eligibility criteria.

- If accepted, the candidate will be required to submit admission fee of Rs 41,220/- through online mode (eligibility and migration fee will be in addition to the admission fee and shall be applicable from case to case).
- The admission is provisional subject to the verification of original documents.

Important Notes: -

1. The distance learners are required to create **UCG-DEB-ID** on URL link: [https://deb.ugc.ac.in/Student DEB-Id](https://deb.ugc.ac.in/Student%20DEB-Id) before proceeding further for the admission.
2. Important instructions for filling in the admission form online will be available on Website www.distanceeducationju.in.
3. The University/ Centre has not authorized any person/ agency to conduct admission on its behalf.
4. Mere submission of Online application does not guarantee admission.
5. The candidate has to submit hard copy of the application form within 2 working days from the date of filling the online application form.
6. The admission shall be provisional and subject to the scrutiny of the original documents.
7. After the successful acceptance of the form the candidate has to pay total admission fee of **Rs 41,220/-** through online mode for all semesters (eligibility and migration fee will be additional).
8. Reservation policy shall be applicable as per the rules / norms applicable in Jammu and Kashmir Union territory/ University of Jammu.

The students are advised to upload the following documents:

1. Degree Certificate of UG/PG or equivalent course.
2. Two years Teaching Experience Certificate.
3. Category Certificate (Whichever applicable).
4. Diploma in Education / D.EL. Ed. / N.T.T).
