Online applications as per the prescribed format are invited from the eligible candidates for admission to the Under Graduate Programmes i.e. B.A and B.Com Sem.-I (Non CBCS), to be offered in (ODL) Open & Distance Learning mode, through the Centre for Distance & Online Education, University of Jammu and its Learner Support Centres established at **Kathua, Udhampur, Rajouri and Baderwah** (UG Programmes only). Interested candidates can fill up the online application form through the Website **[www.distanceeducationju.in](http://www.distanceeducationju.in)**.

The fee has to be deposited through online mode available for the purpose, (Internet payment gateway) at the above referred website.

Note: The Distance Learners are required to create ABC (APAAR ID) from Digi-locker app and UGC-DEB-ID on <https://deb.ugc.ac.in/Student-DEB-Id> before proceeding further for the admission.

**Eligibility**

**For B.A & B.Com Programmes**

- i) Candidates who have passed the Higher Secondary Part-II (10+2) examination of the J&K Board of School Education or any other examination recognized as equivalent there to by the University of Jammu, shall be eligible for admission to Three -Year Degree (General) Programme Semester-I. However, those who have cleared their said examination from Board other than J&K Board will

have to submit Migration Certificate (in original) along with duly filled in eligibility form with prescribed fee as applicable, and an Affidavit as given in Annexure-I.

- ii) Candidates who have passed the Higher Secondary Part-II (10+2) examination in Commerce subjects from the J&K Board of School Education or any other examination recognized as equivalent thereto in any stream (Other than Commerce) obtaining not less than 45% marks in the aggregate shall also be eligible for admission to the B.Com Degree (General) Programme Semester-I. However, those who have cleared their said examination from Board other than J&K Board will have to submit Migration Certificate (in original) along with the eligibility form duly filled in and an Affidavit as given in Annexure-I.
- III) In case of candidates having a 'gap' of more than one year after 12<sup>th</sup>, such applicants must attach a Notary Certified Affidavit for Gap period. The specimen has been given as Annexure-II.

The hard copy of the online admission form must be submitted **BY HAND** in the respective offices i.e Room No. 8 for B.A and Room No. 16 for B.Com Ground Floor, CDOE Main Building along with all relevant documents as follows:
