- Candidates are required to create their unique DEB -ID on URL link: <https://deb.ugc.ac.in> before proceeding to fill the online admission form.
- The fee has to be deposited through online mode (Internet payment gateway) available on the Website (www.distanceeducationju.in).
- Eligibility fee @ Rs.1120/- Registration fee @Rs. 580/- Registration Revival fee @ Rs. 660/- wherever applicable, shall also be paid by the candidates who have qualified the previous degree from Universities/ Institutions other than University of Jammu.

Further, the candidates are required to submit the hardcopy of the form along with the relevant documents i.e original fee receipt/ Migration Certificate/ Transfer Certificate (if any)/ Provisional Certificate/ NOC (if any)/ Affidavit/ Undertaking), **by hand** in the concerned P.G Section of the Centre for Distance and Online Education, University of Jammu, Jammu. The candidates must submit the hardcopy of application form along with above mentioned documents within **05 working days** from the date of submission of the Online form. No form shall be entertained after the due date of the submission of Online forms.

Note:- The candidates whose result for semester VI of Under Graduate Exam. is not yet declared, they shall be provisionally admitted on the basis of having qualified all the semesters upto sem V (I to V sem in all). However, the admission shall be provisional and confirmed only after passing the VI semester. It is mandatory to qualify and submit the marksheets of VI sem within stipulated time as notified separately by the CDOE.
